ORDER

WHEREAS in terms of Section <u>15(1)</u> of the NCTE Act, 1993 SANT BABA HARI SINGH MEMORIAL KHALSA COLLEGE OF EDUCATION, VPO- MAHILPUR, DISTT. – HOSHIARPUR, PUNJAB has submitted an application <u>(code No.APN03176)</u> to the Northern Regional Committee of NCTE for grant of recognition/permission for starting (ETE) <u>D.Ed. course</u> of <u>two year</u> duration with an annual intake of 50 (Fifty) students on 23.10.2006.

2. Course</u> of Elementary (level) of two year duration with an annual intake of 50 (Fifty) students from the academic session 2008-2009 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:

- (i) The admission in the institutions so recognized for the academic session 2008-2009 shall be made only after affiliation by the examining body, before the commencement of the academic year and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic year 2008-2009, failing which the recognition will be deemed to be for the next academic year i.e. 2009-2010.
